SECTION 1: NO VENUE RENTAL FEE

The Venue does not charge a flat rental fee. All events operate under a Bar Revenue Guarantee model.

SECTION 2: BAR REVENUE GUARANTEE

Client guarantees that the Venue bar will generate a minimum of \$_____ (“Guaranteed Bar Minimum”).

If actual bar revenue during the event is less than the Guaranteed Bar Minimum, Client agrees to pay the difference immediately following the event.

Example:

Guaranteed Minimum: \$1,500

Actual Bar Sales: \$1000

Balance Due by Client: \$500

SECTION 3: PAYMENT TERMS

A non-refundable deposit of \$_____ is required to secure the event date and will be applied toward the Guaranteed Bar Minimum.

Any remaining balance owed must be paid the same night of the event or within 24 hours.

SECTION 4: PROMOTION RESPONSIBILITY

Client is fully responsible for promotion, turnout, and guest engagement. Failure to meet attendance expectations does not waive financial responsibility.

SECTION 5: ALCOHOL & BAR SERVICE

All alcohol must be sold and served exclusively by Venue staff. Outside alcohol is prohibited.

SECTION 6: SECURITY & CONDUCT

Security staffing is determined by the Venue. Disorderly conduct may result in event termination without refund.

SECTION 7: DAMAGE & LIABILITY

Client assumes responsibility for any damages caused by guests or vendors.

SECTION 8: PROMOTION & BRAND USE

Venue branding and logo usage require prior written approval.

SECTION 9: INDEMNIFICATION

Client agrees to indemnify and hold harmless the Venue from any claims arising from the event.

SECTION 10: GOVERNING LAW

This Agreement shall be governed by the laws of the State of Florida.
